(Letter of introduction from the program or Program I.D. required)
- HU Affiliated Programs (Letter of introduction from the program or Program I.D. required)
- HU Alumni (Photo ID required) [\$20 fee/day] * 3 days/yr free
- HU Extension School Students, part-time
(Registration receipt required. Must document need to use the collection, e.g. class on law, government, Islamic studies)
- New Faculty, Staff, Fellows, Retirees (Letter of appointment or HUID required)
- Guests of HU or HLS Students/Staff/Faculty (Must be accompanied by HU affiliate OR have a letter of introduction from HU faculty or staff)
- Incoming Students (Letter of acceptance or HUID required)
- Cross-registered/auditing MIT, BC or other student taking class at Harvard Law School

Academic Affiliates

- Law Students OUTSIDE BOSTON AREA (Law School ID required.)
 - International*

- Law Students IN BOSTON AREA
 - \$20/day * 3 days/yr free

 - Letter from reference librarian
- BAR/BRI students (Bar Review Program ID required) [\$20 fee for 2 months]
- College or University Students (School ID required)
 - \$20/day * 3 days/yr free
 - ARL Institution or MIT **
 - Letter from reference librarian
- College or University Faculty, Staff, Librarians, or RA (School ID OR letter of introduction required)
 - International*
 - Within U.S.*
- PhD Candidates or Graduate Students (Must provide an academic letter of introduction OR document a specific need to use a part of the collection)
 - International*
 - Within U.S.*
 - ARL Institution (BU, BC); or MIT
- Librarian - NELLCO, LLNE, AALL, AALS, ABLL (Employer ID, business or membership card required)

Collection Users [1-3 days. Inquire about extension.]

- Users of Government Docs: US or EU *Depository* items
- Users of materials unique to HLSL, except Special Coll. (Patron must provide citations or letter from reference librarian stating that HLSL is only area library where cited materials are available)

Government Affiliates/Non-Profit Access

- Government Employees, i.e., Federal, State, City, Court (Business card OR government ID required)
- Employees of non-profit organization (Organization ID OR letter of introduction) [\$20/day] **

Standard Access

- Employees of for-profit law firms, corporations, or self-employed researchers [\$20/day]
- No affiliation with any categories above [\$20 fee/per day] (Reduced fee for a week or longer, see below)
