Guidelines

Law School

First-year students must complete the 1L curriculum, including all 1L required courses and a spring elective course chosen from the upper-level curriculum (minimum of 2 and maximum of 4 classroom credits). In the 2L and 3L years, students must earn a total of 52 credits, 10 of which may be earned in GSAS courses, tutorials, or, with the Law School Advisor’s permission, dissertation work. Students must be in residence at the Law School for five fall or spring terms and for three winter terms.

GSAS

Students must have 16 half-courses to graduate. Two years of full tuition and two years of reduced tuition are required for obtaining a PhD unless the student completes the degree requirements in fewer than four years. Specific degree requirements are determined by individual programs.
